Richards will act as Chief Executive Officer until such time as a suitable replacement for the Chief Executive Officer role has been identified.

Levin resigned as Chief Executive Officer of Archway Programs to pursue other interests. She has been working in the nonprofit healthcare industry for over thirty years. She has been at Archway Programs for the past seven years. Since Levin has been at Archway, the organization has experienced economic growth, increased job opportunities, careers programming advancement, increased development of ABA services, innovative new programs and began Archway's rebranding efforts.

Tim Titus, Board Chair at Archway Programs commented, "I would like to thank Marge for doing an outstanding job as our Chief Executive Officer over the last seven years, and for her service to Archway since joining us in 2002. We are grateful for her positive impact on Archway Programs and wish her continued success. Archway is far stronger, and in better shape, than when Marge took over as Chief Executive Officer of Archway Programs. Archway's financial condition and outlook for 2018 remains very positive and unchanged, and our commitment to continued, multi-year profitable growth is not affected. Archway Programs has developed solid management processes, has an experienced executive leadership team, and our finance management team has great depth and expertise."

Levin appointed Richards as Chief Financial Officer in early 2016 and is confident he will successfully lead Archway Programs in the role of interim Chief Executive Officer. Richards also serves on the board at Archway Programs and is an active member in the South Jersey community. Richards has led several nonprofit organizations and significantly improved their fiscal growth over the past two decades.

"We are fortunate to have someone with George's leadership, financial acumen and operational experience to take the helm as Interim Chief Executive Officer at this time, and the board is confident that he is the right person to guide Archway Programs, while delivering value in a transforming environment.
